

# Privacy Policy for TraXion

This Privacy Policy explains how Pluma Technologies Limited's TraXion, registered in the Republic of Ireland, with registered office address at Unit 3D North Point House, North Point Business Park, New Mallow Road, Cork, 902, Ireland, collects, stores, uses and protects personal information. You accept this Privacy Policy when you use TraXion's services or any other features, technologies or functionalities offered by TraXion on TraXion's website [traxion.tech](https://traxion.tech) or through any other means. Terms of Service and Privacy Policy are set of rules which regulate the relationships between Purchaser and [traxion.tech](https://traxion.tech). You cannot accept it partially; this set of rules should be accepted in full. TraXion cannot comply with the requirements of all jurisdictions worldwide while doing business. If any provisions of this document break, transgress or violate the law to which you are subjected to, the law of your jurisdiction shall prevail. Entering into relationship with TraXion, you shall oblige your jurisdiction law. TraXion may withdraw from this Privacy Policy which each of you have accepted, i.e. to refuse the further service.

## Collection of Information

When you use TraXion's website [traxion.tech](https://traxion.tech), you may provide your personal information voluntarily, including but not limited to your name, residential address, email address, and digital wallet address or bank account information, depending on your method of payment. In addition, you may provide some information involuntarily such as any information sent to TraXion by your computer, cell phone, or other access device. This information may include your IP address, device information, including but not limited to identifier, name and type, operating system, location, mobile network information and standard web log information, such as your browser type, traffic to and from [traxion.tech](https://traxion.tech) and the pages you accessed on [traxion.tech](https://traxion.tech). In addition, TraXion may collect personal information from or about you in other ways such as your interaction with customer support or contractual relationships with TraXion. TraXion is not obligated to collect any of your information and may do it at its own discretion.

## Setting up and Using an Account

In order to purchase tokens through [traxion.tech](https://traxion.tech), you are required to set up a personal account and provide your personal information such as name and email address to secure your access to your account. You are responsible for relevance and validity of information to be provided when registering an account. TraXion may require you to provide additional information to verify your identity, address, source of funds or any other information in your account, such as your date of birth, copy of ID, citizenship, country of residence, and other information directly or through a third party. TraXion is not obligated to verify your identity or any other personal information and may do it at

its own discretion. You can review your personal information inside of your account. You can edit your personal information or delete your account by contacting TraXion customer service. If you cancel or delete your account, TraXion may keep your information in its database. This may be necessary to deter fraud by ensuring that a person who tries to commit fraud will not be able to avoid detection simply by closing his/her account and opening a new account. However, if you close your account, your personally identifiable information will not be used by TraXion for any further purposes, nor sold or shared with the third parties, except as necessary to prevent fraud or money laundering and assist law enforcement in accordance with this Privacy Policy. TraXion has the right to enter into relationship with anyone on special conditions (including commercial conditions) which may be different from those stipulated by this Privacy Policy.

## Use of Cookies

TraXion or its partners may place small data files (cookies) or pixel tags on your computer or other device when you access traxion.tech. TraXion may use these technologies to recognize you as a returning user, customize its services, content and advertising, evaluate marketing activities, and collect information about your computer or other access device. TraXion may use various cookies, including but not limited to session cookies, persistent cookies, and "flash cookies." TraXion may codify its cookies to limit access of third parties to the received information. You can independently control the use of cookies from your browser or browser add-ons; however, blocking or disabling TraXion's cookies may interfere with your use of traxion.tech. TraXion is not obligated to place cookies on your computer and may do it at its own discretion.

## Use of Log Files

TraXion may use the log files to collect your Internet protocol (IP) addresses, type of browser, Internet Service Provider (ISP), date/time stamp, referring/exit pages, and number of clicks to analyze your activity on the Site, collect geographic and demographic information, and evaluate content of the traxion.tech. Information collected from log files is not personally identifiable. TraXion is not obligated to use log files and may do it at its own discretion. Storing, Using, and Sharing Your Personal Information

TraXion will store your personal information in its database. TraXion may contract third parties to store your personal information. TraXion does not sell or rent your personal information to third parties for their marketing purposes without your explicit consent. TraXion may use your personal information to customize your use of traxion.tech and services; analyze your activity on traxion.tech, evaluate and improve its marketing efforts and for other reasons relevant to your use of traxion.tech and services. TraXion may share your personal information with:

- Third parties who provide services to TraXion for storing your personal information, fraud prevention, marketing and technology, services of a sale; such third parties are bound by contracts with confidentiality and non-disclosure clauses and may not use your personal information for any reason other than specified in this Privacy Policy.
- Escrow or any other processor of your payment.
- Law enforcement, government officials, or other third parties when TraXion is required to provide your personal information by law, subpoena or court order.
- Parent and/or subsidiary company.
- Other third parties with your consent or direction to do so.

## Severability

In the event any provision of this Privacy Policy is found to be invalid, illegal, or unenforceable the remaining provisions of this Privacy Policy shall nevertheless be binding you with the same effect as though the void and unenforceable part had been severed and deleted.
